

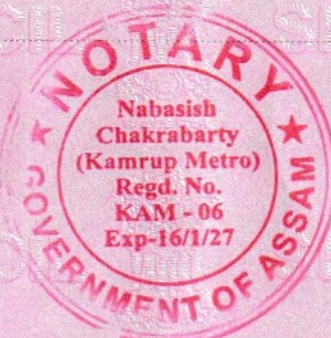

DEED OF TRUST

This Deed of Declaration of the Trust is made at Guwahati this 27th Day of May, 2026, represented by the Governing Body **"PRESIDENT" Dr. Mira Rani Kalita, VICE-PRESIENT, Prof.(Dr.) Deva Kumar Dutta, "SECRETARY" of the Governing Body Shri Bhaben Mahanta and Prof. (Dr). Bairagi Patra-as PRINCIPAL** of the Teachers' Training College, Mirza in the District of Kamrup, Assam.

WHEREAS, The Teachers' Training College, Mirza, is an educational Institution established/founded in the year 1992 and Eastern Regional Committee of NCTE was granted recognition of B.Ed. Course of one year duration with an annual in-take of 100 seat vide ERC order No. ERC/7-76.69(iii)6/2007/8163 dated 04-06-2007 followed by revised recognition order vide No. ERC/NCTE/APE00462/B.Ed. (Revised Order)2015/31759 dated 20-05-2015 for conducting B.Ed. Course of two year duration with an intake of 100 seat from the academic session 2015-2016 as per NCTE Regulation 2014. Besides, the College has been duly affiliated to the University of Gauhati since 2007 with the concurrence of the Government of Assam for the establishment of the college. It is also pertinent to mention herein that due permission and No-Objection Certificate was also granted in the year 2005 by the Government of Assam vide Govt. Letter No .A (I)132/2000/351 dated 23rd September 2005. NCTE has also issued restoration order with and in-take of 100 Seat vide File No. NCTE/2026/ERC/PAR/REST/APE00462/172601-72605 dated 17/01/2026.

WHEREAS, the admission of the college is vested in the Governing Body (GB) consisting of 14 members as per regulation of Gauhati

WHEREAS, the college is standing over a plot of land measuring 3027.36 Sqmt, owned and possessed by the **Teachers' Training College, Mirza**, which is covered by Dag Number-1181 (Old)2607 (New), Plot No. 2607 in the village-Kochpara, Circle- Palasbari, Mouza- Chayani, Kamrup in Assam. The total build-up area consisting of an Assam Type house and a G+2 RCC building is 3419.00 Sqmt. The RCC building was completed in the year 2022. The RCC Building is well equipped with all the norms of infrastructural facilities as prescribed by NCTE norms having Class Rooms, Library Room, Reading Room, Common Rooms, toilets for Boys and Girls, Teachers Common Room, Principal Room, I.T Facilities with Computer Room, Laboratories, etc. with office Room and running water facilities.

WHEREAS, the special Governing Body meeting held on 06/08/2025 considered that it is expedient to make a formal dedication of all the properties of **TEACHERS' TRAINING COLLEGE, MIRZA**, (both immovable and movable) for the purpose of which they were constructed and acquired and to make a more definite approach towards the upliftment of the educational institutions by declaration of public trust in the property already used and now in possession of **TEACHERS' TRAINING COLLEGE, MIRZA**, for the promotion of Teachers education and B.Ed. courses, constituting all the present 8 (Eight) members of the Governing Body as Trustees and authorized the **SECRETARY** of the Governing Body and the **PRINCIPAL ,PRESIDENT** and **VICE- PRESIDENT** of Governing Body of the College to execute a **Deed Declaration of PUBLIC TRUST**.

2. REGISTERED OFFICE :-

The registered office of the 'Trust' shall be at the **Teachers' Training College** building, situated over a plot of land measuring 3027.36 Sqm. which is covered by Patta No..... Dag Number-1181 (Old) 2607 (New), Plot No. 2607 in the village-Kochpara, Circle-Palasbari, Mouza- Chayani, Kamrup in Assam but the Trustees shall be at liberty to transfer the same to such other place as may be determined by them from time to time.

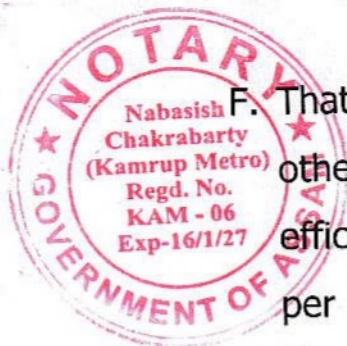
C. That among the trustees, there shall be a President, Vice President, General Secretary, Joint Secretary, and treasurers who shall be elected among themselves and Dr. Mira Rani Kalita shall be the first president and Prof. (Dr) Deva Kumar Dutta, as Vice-President of the 'Trust' and other office bearers will continue to hold their present post as such till the next election is scheduled.

D. That other than the trustees for life, the remaining trustees shall retire at the end of every three years. Their places shall be filled up by the new Governing Body and co-opted members from the sponsoring body.

E. That the 'Trust' shall, in the interest of the college arrange for co-option of sponsoring body members as soon as the number of original sponsors becomes less than 15 among the educationists of the locality and surrounding areas of the college.

F. That the Board of the trustees are also authorized to constitute such other Advisory Committee as they deem fit for the smooth and efficient running of the B.Ed. Course and other related activities as per curriculum and syllabus from the affiliated University in the Teachers' Training College, Mirza.

G. That the decision of the trustees by a majority vote shall be final and binding on all matters for the academic improvement of the college.

H. That the Board of Trust and trustees will conduct the Teacher Education Courses as non profit organization in order to develop the education amongst the teachers in the state.

4. RETIREMENT OF THE TRUSTEES-

(a) Any trustee may retire after giving a three month (90 days) notice in writing thereof to the others.

(b) A trustee shall automatically cease to be and shall vacate the office of the trustees on the happening of any of the following-

(1) By death, resignation or retirement.

(2) If he/she becomes unsound mind.

(3) If he/she is absent from India without permission of the Trustee for a prolong period of more than six months.

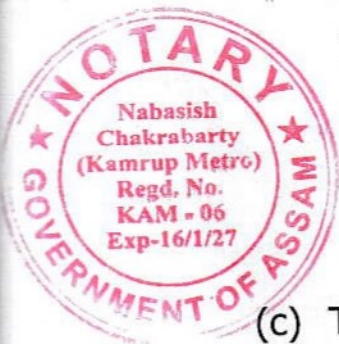
(4) If he/she is convicted for committing a criminal offence and is sentenced to imprisonment for more than six months.

(c) The vacancies created on the happening of any event as mentioned in paragraph 4 (b) shall be replaced or filled up by the trustees with the proper approval of the Governing Body and Sponsoring Body members.

5. OBJECTIVES OF THE TRUST:-

The object of the Trust shall be the following among others-

- (4) To develop competency, commitment and performance among the school teachers, educators for improving quality education in our school system and Higher education system.
- (5) To develop communication skills and use of modern information and technology for Teacher Education purposes for reconstitution of knowledge.
- (6) To disseminate knowledge and wisdom through quality education to serve better individual and social life in the society.
- (7) To provide opportunities for co-curricular education for socio cultural activities.
- (8) To hold meetings, seminar, symposium, debates, discussion among individuals and groups for the

benefits of the society, especially among students and Teacher community.

- (9) To publish Magazine and Books/ journals for development of Teacher Education in the state.
- (10) To arrange for extension of relevant academic facilities among the trainees of B.A/ B.Ed./ITEP Courses as approved from the affiliating university.

6. TRUST FUNDS:-

That the funds of the 'Trust' shall consist of the fees collected from the students at the time of admission, gift, donations, assistance of the public and Government received in favour of the trust.

The Trustees may accept donations and contributions, as gifts or otherwise from any person, corporation, institution, State or Government of any country or from any other Trust; and all these may be accepted in any form, such as money, bullion, ornaments, machinery, royalties, rights, licenses, concessions, useful animals and movable or immovable property of all kinds.

Provided, however, that the Trustees may decline to accept any such donations or contributions at their discretion without assigning any reasons therefore.

7. DURATION OF THE TRUST-

(a) The creation of the trust is irrevocable and its duration perpetual and permanent subject to the other clauses of this deed.

8. TRANSACTION OF BUSINESS BY THE TRUSTEES-

That the Trustees shall meet once in every 3 months or as may be necessary for the proper conduct of the affairs of the 'Trust'. Such meeting shall be presided over by the President of the 'Trust' or in his absence or inability by the Vice-President of the 'Trust' and in his absence or inability by one of the trustee elected by the trustees. All decisions of the 'Trust' shall be by a simple majority except as otherwise expressly provided therein.

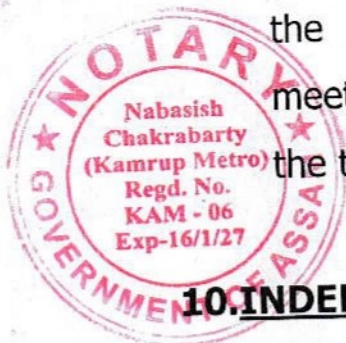
9. ACCOUNTS AND MINUTES-

Trust and that the Trust may succeed in the name of President/Secretary of the Trust.

12. That no portion of the 'Trust' money shall be lent out to, or kept in deposit with, any of the Trustees or any firm in which any of the Trustees may be a partner nor shall any of the Trustees apply any portion of the 'Trust' property or fund for his own use or benefit either directly or indirectly

13. That all the main account books of the 'Trust' shall be kept at the head office of the 'Trust' or at such other places as the Trustees may decide. The branches of the Trust, wherever established, may if desired by the Trustees, maintain separate accounts of their own, which shall be incorporated in the Head Office accounts and when considered proper and convenient but not later than the annual closing.

14. That the Trustees may, in the conduct of the 'Trust' business, employ agents and other employees and pay them salary or commission as they may, at their discretion, consider necessary, and delegate to or confer upon these agents or employees such authority and power on behalf of the 'Trust', as the Trustees may deem proper.

That the Trustees shall have full power and discretion to acquire, hold, carry on and manage any trade or business or any part thereof, and to employ the whole or any portion of the Trust property or any funds of the Trust in such trade or business, or in running concerns or managing agencies, or in securities or shares and debentures of public or private limited companies or other investments and realize or vary the same or any branch or portion thereof, as they may deem proper from time to time, provided however, that the income profits and gains thereof shall be utilized and applied only for and on behalf of the Trust as provided herein.

19. That the Trustees may, at any time, if they consider it necessary or beneficial to the Trust, raise or borrow money for the use and benefit of the Trust on any terms, and on any security or otherwise, as they may consider proper.

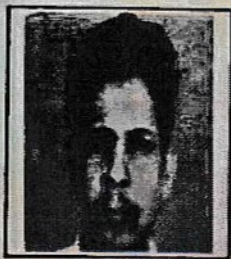

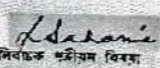
